SEPA MITIGATION MEASURES

Conditions of approval

- 1) The City shall provide opportunity for the Tribes to review and comment on final design of the proposed overpass/bridge project.
- 2) If new development is proposed within 200 feet of the Floodway or Ordinary High Water Mark, then prior to permit issuance for that portion of the development the proposal must obtain a Substantial Shoreline Development Permit.
- 3) If the footprint of any new development is proposed within the floodplain, then additional analysis consistent with SMC 15.52, SMC 16.40 and SMC 16.56 must be provided as part of the final design.
- 4) In the event that archaeological materials are encountered during the development of the property, an archaeologist shall immediately be notified and work halted in the vicinity of the find until the materials can be inspected and assessed. At that time, the appropriate persons are to be notified of the exact nature and extent of the resource so that measures can be taken to secure them. In the event of inadvertently discovered human remains or indeterminate bones, pursuant to RCW 68.50.645, all work must stop immediately and law enforcement should be contacted. Any remains should be covered and secured against further disturbance, and communication established with local police, the DAHP, and any concerned tribal agencies.
- 5) A noise study that quantifies and analyzes the project's potential noise impacts and mitigation measures will be completed as part of the NEPA process and in accordance with WSDOT protocols and standards.
