Certificate of Inspection

The owners/operators of air supported amusement structure(s) agree to provide a Certificate of Inspection demonstrating the completion of a safety inspection completed by a certified safety inspector. Certificate of inspection: The amusement ride inspector or insurer per RCW 67.42.020 (2) must certify that the amusement ride or structure has been inspected for safety and meets the standards for compliance with all applicable requirements of the National Electrical Code and this chapter, manufacturer's specifications, American Society of Testing and Materials (ASTM) Standards on Amusement Rides and Devices, and insurance company inspection requirements. Amusement rides or structures that undergo major modification must be recertified by an amusement ride inspector or insurer per RCW 67.42.020 (2) before being placed into operation. The inspection must be completed by a Washington State Labor and Industries Certified Amusement Ride Inspector.
