## NOTICE OF DECISION

NOTICE IS HEREBY GIVEN that the City of Sumner's Hearings Examiner has issued a decision for a **Shoreline Substantial Development Permit, Shoreline Variance and a Shoreline Conditional Use Permit** for the project described below.

Project Name: 410 Traffic Ave Interchange

**Permit Application No:** PLN-2018-0074

**Locations:** Highway 410 and Traffic Ave interchange and overpass

**Description of Proposal:** The City of Sumner is proposing to add general purpose lanes and non-motorized facilities on Traffic Avenue between the five lanes, E. Main Street Bridge, over the Puyallup River and the five lane-lane section of Traffic Avenue extending north towards downtown Sumner. The most significant section of work will include adding a lane in each direction to the existing two lanes bridge crossing over SR410. This would be done by building a separate parallel structure to carry new general-purpose lanes and non-motorized facilities. The project will reconfigure intersections at each end of the existing SR410 overpass that connect to the SR 410 access ramps and Thompson Street. The south end of the project will connect to Puyallup's Riverwalk Trail, the Sumner Link Trail, and Pierce County's Foothills Trail system. Non-motorized facilities will be installed through the length of the project to provide an ADA accessible pathway connecting to the Sound Transit Sounder Rail Station. Work within the shoreline jurisdiction is limited to 6,225 SF of new sidewalk, 2 new curb ramps on the new sidewalk, 1,510 CY of fill, 35 CY of compensatory flood storage excavation, 310 feet of new guardrail, 1 new guardrail anchor, 115 feet of replaced fence, 165 feet of new 10-inch sanitary sewer force main, 30 feet of 12-inch storm sewer, 2 new catch basins, 1 new luminaire, 1 new signal pole, 1 new pedestrian signal pole, and 1 new controller cabinet.
