

SEPA ENVIRONMENTAL CHECKLIST

Senior Housing Incentives and Code Updates – Sumner Municipal Code amendments to expand where senior housing, including senior apartments, can be built, and to provide flexibility in all Zoning Code standards to accommodate senior housing throughout the city while addressing potential impacts of increased density and apartments in residential zones. Code amendments will update various sections of the Zoning Code, such as reducing parking and open space requirements for senior housing, allowing stand-alone senior apartments in commercial zones, and updating Planned Residential Development standards to allow density bonuses and building height increases for senior housing. There is no project associated with this proposed code update.
