

SEPA ENVIRONMENTAL CHECKLIST

The proposal is to update regulations in the Subdivision Code and Zoning Code to raise the threshold for a short subdivision to 9 lots, allow pipestem lot short subdivisions to have up to 4 lots, to update access standards to allow a shared driveway for up to 4 dwellings and allow a narrow private drive aisle for up to 9 dwellings. Proposed code changes also include: Allowing pipestem lot sizes and building height to be the same as all lots in the zone, and adjusting setbacks for pipestem lot development, and establishing a maximum lot size for new single-family dwellings in Medium- and High-Density Residential zones. There is no project associated with this proposed code update.

- The proposal is to update regulations in the Subdivision Code and Zoning Code to raise the threshold for a short subdivision to 9 lots, allow pipestem lot subdivisions to have up to 4 lots, to update standards for these types of subdivisions, and to streamline the permit process. City code already allows for these types of subdivisions. If adopted, the code would encourage single-family infill citywide, thereby potentially increasing housing density. However, the potential increase in housing capacity in the city would not encourage land uses that are incompatible with existing plans.***

Proposed measures to avoid or reduce shoreline and land use impacts are:

- The proposal encourages housing infill development, potentially creating more dwelling units throughout the city. However, the increase in housing capacity occurs within city limits where transportation and public services are already available; therefore, the proposal is likely to have only a negligible effect on demand for public facilities.***
