



## **DETERMINATION OF NON-SIGNIFICANCE**

**Proposal:** XCJ Corp facility will be used to produce dumplings, noodles, and sauce. A State Water Discharge Permit to Discharge Industrial Wastewater to POTW is required because the facility will discharge wastewater to the City of Sumner's POTW. The facility's existing pretreatment equipment can accommodate a maximum wastewater discharge flow of 56,000 gallons per day (gallons/day) and an average wastewater discharge flow of 45,000 gallons/day (averaged over a month). Production at the XCJ facility would initially result in monthly wastewater flows of 23,000 gallons/day on average, but it would gradually increase up to 45,000 gallons/day on average and less than 56,000 gallons/day as a maximum, as the facility's food production volume increases over time. Wastewater would be stored outside in existing tanks with double containment. No new equipment is being installed at the facility
